First is the Bharat Griha Raksha, which will cover home building and home content, and provide coverage against fire, natural catastrophes, riots, acts of terrorism, and other risks within seven days of occurrence. Second is the Bharat Sookshma Udyam Suraksha, a standard product for enterprises for which the total value at risk is up to Rs 5 crore. Bharat Laghu Udyam Suraksha, the third, will cover enterprises for which the total value of risk across insurable asset classes at a single location exceeds Rs 5 crore, but not Rs 50 crore at the policy commencement date.

This workshop is aimed at covering the aspects of coverages of all the three standard products and also discusses about the comparison and contrast with their respective products.
