

ADVERTISEMENT FOR THE POST OF PRINCIPAL, IIRM

IIRM is a leading Business School in Hyderabad promoted jointly by Insurance Regulatory and Development Authority of India (IRDAI) and Government of Telangana and is looking for a Principal for its Academic and related activities. The Institute is recognized by AICTE and has its own Residential Campus located in the Financial District, Hyderabad. The Institute offers, among others, a Post Graduate Diploma in Management (PGDM), which is a 2-year Master's level program accredited by AICTE, with various specializations. Apart from providing management education, the Institute regularly conducts training programs and Distance Learning courses for various segments of the BFSI sector, in general and Insurance sector, in particular. The Institute also undertakes collaborative research on various facets of BFSI sector.

Key responsibilities of the Principal :

The Principal will provide academic leadership to the Institute under the guidance of Board level Committees as also various other internal committees. The Principal will ensure conducting programs and courses as prescribed and to constantly evaluate and monitor the curriculum based on the suggestion of Academic Committee as required from time-to-time. The list of duties and responsibilities of the Principal are given in (**Annexure 1**), which is illustrative but not exhaustive.

Eligibility Criteria :

1. The age of the applicant should not be less than 55 years and **not** more than 58 years as on 01.01.2026.
2. The qualification and experience criteria of the applicant should be as per AICTE rules viz.
 - a. Ph.D. Degree in Management or Risk Management or in any of the areas of programmes offered by the Institute.
 - b. First Class or equivalent at either Bachelor's or Master's level in the Management in accordance with the guidelines of AICTE.
 - c. Should have guided at least two successful Ph.D. candidates as Supervisor/ Co-Supervisor.
 - d. Minimum 8 research publications in SCI journals / UGC / AICTE approved list of journals.
 - e. Minimum 20 years of experience in teaching / research/ industry, out of which at least 5 years shall be at the post equivalent to that of Professor in any Management Institute.

Pay Structure :

Professor – Grade II – 100,000-4,500-118,000-6,000-142,000 (Basic Pay + 35% DA + 30% HRA and other allowances as applicable to the grade).

Nature of Employment :

1. The nature of employment would be on a regular scale with the allowances applicable to the Grade as per the Institution's pay scale structure and conditions as per the service rules of IIRM.
2. The appointment will be on probation for one year from the date of joining and the services will be confirmed depending upon the satisfactory performance, based on review after completion of one year period.
3. As per the Service rules of IIRM, the age of superannuation of the Teaching staff is 65 years.
